Please read the following statements. If you are in agreement and will abide by these policies, sign at the bottom and return. "We" refers to BOTH parents.

1. We understand that due to the ambiguous political and legal position of private independent study programs, Desert Christian Home Education Program (DCHEP) cannot offer legal immunity and is only providing services to those involved in this ministry. We will keep our Home School Legal Defense Association membership current. We also understand that the school deals directly with the parents (or legal guardians) in all matters, including legal and financial and that the student must be under the jurisdiction of his parents or legal guardians as a condition of enrollment and graduation, regardless of age.
2. We have read, understand and agree to abide by all parent responsibilities as listed in the *DCHEP Handbook for Parents*, and agree to the policies contained within it, including the *Concern Resolution Process* on page 10. We accept the responsibility of obeying the rules and regulations by which the school is operated and we accept the responsibility to support the Christian principles for which it stands.
3. We have joined DCHEP for the purpose of like-minded support and encouragement, accountability, and fellowship. Therefore, we will do our best to support our fellow-members and school activities by participating and serving in both areas.
4. We have read the statement of faith and uphold these doctrines to be true.
5. We understand that DCHEP is a tuition-based ministry and we will be responsible to satisfy the registration fee of \$50 for the first child, \$25 for each additional child (\$100 maximum per family), and the yearly tuition. For families with 1 or 2 children enrolled, tuition is \$858 per year payable August through June at \$78 per month. Families with 3 or more children enrolled pay \$1034 per year at \$94 per month for 11 months. *An additional fee of \$55 per year (\$5 per month) is assessed to the tuition fees of each high school student.* We further understand that tuition is due on the 1<sup>st</sup> of each month; payments made after the 10<sup>th</sup> of the month are subject to a \$50 late fee, and that no statement will be mailed.
6. We hereby grant permission for our child/children to be included in evaluations and pictures connected with the school program.

**Consent to Policy**

We have read the Membership Agreement and the Statement of Faith and agree to abide by them. It is understood that if we no longer consent to these statements or policies this agreement becomes null and void and our membership in DCHEP is terminated.
